Decorative acrylic marble render KULIRPLAST, KPT.

· Product category

KULIRPLAST is acrylic render made of multi-coloured marble granulate. It is available in a large number of shades.

· Application of the substance / the mixture

KULIRPLAST is manufactured in granulations 1.5, 2.0 and 3.0, and intended for decorative protection of all types of fine plastered façade surfaces, especially plinths. It is also used for heavily exposed interior wall surfaces of halls, staircases and similar. It adheres well to all fine-coarse construction surfaces including: base-coats of ETICS systems (it is suitable for systems based on insulation boards made of expanded or extruded polystyrene), classic fine lime-cement and cement renders, smoothed concrete surfaces and also fibre-cement and gypsum-cardboards, chipboards and similar.

Processed surfaces have typical evenly grained appearance. It is distinguished by high hardness and good resistance to the effects of smoke, ultraviolet radiation and other atmospheric factors. We advise against the application of the product onto surfaces of tall buildings which are heavily exposed to precipitation and it is also not suitable for the protection of horizontal surfaces or any surfaces laden with foot traffic. Processed surfaces are provided with long-term resistance to contamination with wall mould. Therefore, it is not necessary to add any biocidal substances prior to application.
